

**RSD2 ZONED HIGH SCHOOL AND WAIVER REQUEST FORM
FOR MIDDLE SCHOOL ATHLETIC ELIGIBILITY ON HIGH SCHOOL SPORTS TEAMS**

Note: This form must be completed for each semester. Approval must be granted before any seventh or eighth-grade student can compete in a sport at a high school. A student can only play sports at a high school other than the one for which the student is zoned if the student qualifies for one of the allowances below.

Step 1: Parent completes the waiver form and returns the completed and signed form to the middle school athletic director.

Step 2: Middle School Athletic Director verifies the student's athletic eligibility, signs the document, and sends the document to the Registrar's Office.

Step 3: Registrar's Office verifies future school attendance eligibility and sends the document to the Office of the Executive Director of Student Services for final approval.

Step 4: The Office of the Executive Director of Student Services sends the final decision to the parent, school, and Registrar's Office.
