I hereby authorize my above-named child to receive training in the safe operation of a motorized utility vehicle and to operate a motorized utility vehicle (e.g., golf cart or similar low-speed vehicles) () on school property in connection with his/her participation in _____ [list name of school-sponsored activity] under the direction of _____

The right to operate a motorized utility vehicle is a privilege that may be suspended or revoked if a student violates relevant Board of Education policies and/or administrative guidelines, provisions of the Student Code of Conduct, or State or local laws, including traffic rules and regulations, while s/he is operating the motorized utility vehicle, or while on school property or off school property at school-sponsored events. All provisions of the Student Code of Conduct and Board policies shall be in effect while the student is off school property and participating in a school-sponsored activity, and the student is expected to comply with all such rules and regulations. Violations of such rules and/or regulations may result in appropriate disciplinary action.

() The student's operation of motorized utility vehicle involves an assumption of liability on the part of the student and his/her parents, and a responsibility in the care of property and in the observation of safety rules. The Board, its officers, employees, representatives, and agents shall not be responsible for motorized utility vehicles that are stolen or damaged, and/or for injury, death or loss to persons or property resulting from a student's operation of the utility vehicle as part of the above-identified school-sponsored activity.

() A student authorized to operate a motorized utility vehicle as part of a school-sponsored activity shall be solely liable for any injury, death or loss to persons or property related to or caused by his/her operation of the vehicle, and his/her motor vehicle insurance shall be the primary insurance in any accident.
