Section I: Required Documentation- Upon presentation of this application, the parent/legal guardian must have:

1. **Proof of Residence:** When registering, the student(s) and parent(s) must provide documentation of physical address. Acceptable verifiable documentation includes a current electric/water/sewer bill, a current and signed rental agreement, an approved transfer form, proof of guardianship or valid receipt, and a letter on property letterhead indicating the student is staying in a hotel or rental condominium for the long term. A driver’s license and voter registration card may be used to verify address but will not serve as sole evidence. At the time of registration, parents will be asked to provide the vehicle license tag numbers of all vehicles that will be picking up or dropping off students on a regular basis.
2. * Most recent **report card and final report card from the previous school year** (180-day period) (each sport)
3. * Student **Physical Examination/Parent Permission Packet** completed, signed, and attached (once per year)
4. * **State-certified copy of Student’s Birth Certificate** attached (will be returned to a student; one time only for entire school career)

Defined Extracurricular Activities include those activities sponsored solely by the resident school, carry no academic credit, do not fall within the scope of the regular curriculum, or require enrollment in a class during the regular academic day at the resident school.



The Equal Access to Interscholastic Activities Act gives home school students access to interscholastic activities offered by the public school that serves their area of residence. This means that students will be permitted to participate in any extra-curricular activity for which they qualify. Please note the key points that are outlined below:

Key Points for Home School Students

- This access is only available at “traditional public schools,” not exclusive magnet schools, exclusive technical schools, charter schools, home schools, and/or private schools.
- The home school student must be a full-time home school student **prior to participating in an interscholastic activity.**
- **The home-schooled student must have been taught in the setting for a full academic year prior to participating in an interscholastic activity. The student may satisfy this requirement by being home-schooled for a full academic year at any time prior to participation.**
- **The student must notify the appropriate high school athletic director listed below in writing of his/her intent to participate in the interscholastic activities as a representative of the school before the beginning of the season (first day of legal practice) for the activity in which he/she wishes to participate.**

- The home school student must reside (with League-recognized guardians) in the attendance zone of the public school in which the student participates. (SCHSL)
- The student must meet all League requirements at the resident public school except enrollment and attendance. (SCHSL)
- A student who changes residence (by League's) transfer standards eligibility will transfer to the new residence school immediately. (SCHSL)

All applicable paperwork needs to be completed and returned to the athletic director of the school in the attendance zone in which the student resides. Once the student's paperwork has been received and processed, the student will be placed on the eligibility list for the sport in which the student desires to participate.
