A MESSAGE TO ALL VOLUNTEERS

As part of Colfax School District's procedures to ensure student safety, individuals who express an interest in volunteering in our schools are required to complete a disclosure form as well as grant us permission to conduct a background check through the Washington State Patrol's on-line system. The procedure, which is similar to that which we currently utilize before hiring employees, will enable us to provide further assurances to you that our school environment is both safe and secure for our children.

Please take a few minutes to **read and complete both sides of this form, and provide a copy of your drivers' license**. The completed form and copy of license may be returned to a teacher, the building principal, the Activities Director, or the District Office. Once we have received this form and have reviewed the results of the on-line Washington State Patrol background check, our staff will coordinate a schedule for you. We thank you for your willingness to give of your time and talents and are most appreciative of your commitment to the students in our district.

WORKERS COMPENSATION

In the State of Washington, school district-provided workers' compensation coverage for volunteer workers is not mandatory. Colfax School District No. 300 does not extend workers compensation benefits to volunteer workers.
