Concussion Information

Concussion is a brain injury. Concussions, as well as all other head injuries, are serious. They can be caused by a bump, a twist of the head, sudden deceleration or acceleration, a blow or jolt to the head, or by a blow to another part of the body with force transmitted to the head. You can't see a concussion, and more than 90% of all concussions occur without loss of consciousness. Signs and symptoms of concussion may show up right after the injury or can take hours or days to fully appear. All concussions are potentially serious and, if not managed properly, may result in complications including brain damage and, in rare cases, even death. Even a "ding" or a bump on the head can be serious. If your child reports any symptoms of concussion, or if you notice the symptoms or signs of concussion yourself, your child should be immediately removed from play, evaluated by a medical professional and cleared by a medical doctor.

Signs and Symptoms of a Concussion:

Concussion symptoms may appear immediately after the injury or can take several days to appear. Studies have shown that it takes on average 10-14 days or longer for symptoms to resolve and, in rare cases or if the athlete has sustained multiple concussions, the symptoms can be prolonged. Signs and symptoms of concussion can include: (not all-inclusive)

- Vacant stare or seeing stars
- · Lack of awareness of surroundings
- Emotions out of proportion to circumstances (inappropriate crying or anger)
- · Headache or persistent headache, nausea, vomiting
- Altered vision
- Sensitivity to light or noise
- Delayed verbal and motor responses
- Disorientation, slurred or incoherent speech
- Dizziness, including light-headedness, vertigo(spinning) or loss of equilibrium (being off balance or swimming sensation)
- · Decreased coordination, reaction time
- Confusion and inability to focus attention
- Memory loss
- Sudden change in academic performance or drop in grades
- · Irritability, depression, anxiety, sleep disturbances, easy fatigability
- In rare cases, loss of consciousness

DANGERS if your child continues to play with a concussion or returns too soon:

Athletes with signs and symptoms of concussion should be removed from activity (play or practice) immediately. Continuing to play with the signs and symptoms of a concussion leaves the young athlete especially vulnerable to sustaining another concussion. Athletes who sustain a second concussion before the symptoms of the first concussion have resolved and the brain has had a chance to heal are at risk for prolonged concussion symptoms, permanent disability and even death (called "Second Impact Syndrome" where the brain swells uncontrollably). There is also evidence that multiple concussions can lead to long-term symptoms, including early dementia.

Steps to take if you suspect your child has suffered a concussion:

Any athlete suspected of suffering a concussion should be removed from the activity immediately. No athlete may return to activity after an apparent head injury or concussion, regardless of how mild it seems or how quickly symptoms clear, without written medical clearance from an appropriate health-care professional (AHCP). In Florida, an appropriate health-care professional (AHCP) is defined as either a licensed physician (MD, as per Chapter 458, Florida Statutes), a licensed osteopathic physician (DO, as per Chapter 459, Florida Statutes). Close observation of the athlete should continue for several hours. You should also seek medical care and inform your child's coach if you think that your child may have a concussion. Remember, it's better to miss one game than to have your life changed forever. When in doubt, sit them out.

Return to play or practice:

Following physician evaluation, the *return to activity process* requires the athlete to be completely symptom free, after which time they would complete a step-wise protocol under the supervision of a licensed athletic trainer, coach or medical professional and then, receive written medical clearance of an AHCP.

Statement of Student Athlete Responsibility

Parents and students should be aware of preliminary evidence that suggests repeat concussions, and even hits that do not cause a symptomatic concussion, may lead to abnormal brain changes which can only be seen on autopsy (known as Chronic Traumatic Encephalopathy (CTE)). There have been case reports suggesting the development of Parkinson's-like symptoms, Amyotropic Lateral Sclerosis (ALS), severe traumatic brain injury, depression, and long term memory issues that may be related to concussion history. Further research on this topic is needed before any conclusions can be drawn.

I accept responsibility for reporting all injuries and illnesses to my parents, team doctor, athletic trainer, or coaches associated with my sport including any signs and symptoms of CONCUSSION. Sudden Cardiac Arrest Information

Sudden cardiac arrest is a leading cause of sports-related death. This policy provides procedures for educational requirements of all paid coaches and recommends added training. Sudden cardiac arrest is a condition in which the heart suddenly and unexpectedly stops beating. If this happens, blood stops flowing to the brain and other vital organs. SCA can cause death if it's not treated within minutes.

Symptoms of sudden cardiac arrest include, but not limited to: sudden collapse, no pulse, no breathing.

Warning signs associated with sudden cardiac arrest include: fainting during exercise or activity, shortness of breath, racing heart rate, dizziness, chest pains, extreme fatigue.

It is strongly recommended all coaches, whether paid or volunteer, are regularly trained in CPR and the use of an AED. Training is encouraged through agencies that provide hands-on training and offer certificates that include an expiration date.

Automatic external defibrillators (AEDs) are required at all FHSAA State Series games, tournaments and meets. The FHSAA also strongly recommends that they be available at all preseason and regular season events as well along with coaches/individuals trained in CPR.

What to do if your student-athlete collapses:

- 1. Call 911
- 2. Send for an AED
- 3. Begin compressions

FHSAA Heat-Related Illnesses Information

People suffer heat-related illness when their bodies cannot properly cool themselves by sweating. Sweating is the body's natural air conditioning, but when a person's body temperature rises rapidly, sweating just isn't enough. Heat-related illnesses can be serious and life threatening. Very high body temperatures may damage the brain or other vital organs, and can cause disability and even death. Heat-related illnesses and deaths are preventable.

Heat Stroke is the most serious heat-related illness. It happens when the body's temperature rises quickly and the body cannot cool down. Heat Stroke can cause permanent disability and death.

Heat Exhaustion is a milder type of heat-related illness. It usually develops after a number of days in high temperature weather and not drinking enough fluids.

Heat Cramps usually affect people who sweat a lot during demanding activity. Sweating reduces the body's salt and moisture and can cause painful cramps, usually in the abdomen, arms, or legs. Heat cramps may also be a symptom of heat exhaustion.

Who's at Risk?

Those at highest risk include the elderly, the very young, people with mental illness and people with chronic diseases. However, even young and healthy individuals can succumb to heat if they participate in demanding physical activities during hot weather. Other conditions that can increase your risk for heat-related illness include obesity, fever, dehydration, poor circulation, sunburn, and prescription drug or alcohol use.

Your school is a member of the Florida High School Athletic Association (FHSAA) and follows established rules. To be eligible to represent your school in interscholastic athletics, in an FHSAA recognized sport (i.e. bowling, competitive cheerleading, girls flag football, lacrosse, boys volleyball, water polo and girls weightlifting or sanctioned sport (i.e. baseball, basketball, cross country, tackle football, golf, soccer, fast-pitch softball, swimming & diving, tennis, track & field, girls volleyball, boys weightlifting and wrestling), the student:

- 1. This form is non-transferable; a separate form must be completed for each different school at which a student participates.
- 2. Must be regularly enrolled and in regular attendance at your school. If the student is a home education student or attends a charter school or Florida Virtual School Full time Program or a special/alternative school or certain small non-member private schools, the student must declare in writing his/her intention to participate in athletics to the school at which the student is permitted to participate. Home education students and students attending small non-member private schools must be approved through the use of a separate form prior to any participation. (FHSAA Bylaw 9.2, Policy 16 and Administrative Procedure 1.8)
- 3. Must attend school within 10 days of the beginning of each semester to be eligible during that semester. (FHSAA Bylaw 9.2)
- 4. Must maintain at least a cumulative 2.0 grade point average on a 4.0 unweighted scale prior to the semester in which the student wishes to participate. This GPA must include all courses taken since the student entered high school. A sixth, seventh or eighth grade student must have earned at least a 2.0 grade point average on 4.0 unweighted scale the previous semester. (FHSAA Bylaw 9.4)
- 5. Must not have graduated from any high school or its equivalent. (FHSAA Bylaw 9.4)
- 6. Must not have **enrolled in the ninth grade for the first time** more than four school years ago. If the student is a sixth, seventh or eighth grade student, the student must not participate if repeating that grade. (FHSAA Bylaw 9.5)
- 7. Must have signed permission to participate from the student's parent(s)/legal guardian(s) on a form (EL3) provided the school. (Bylaw 9.8)
- 8. Must not turn 19 before September 1st to participate at the high school level; must not turn 16 prior to September 1st to participate at the junior high level; and must not turn 15 prior to September 1st to participate at the middle school level, otherwise the student becomes permanently ineligibile. (FHSAA Bylaw 9.6)
- 9. Must undergo a pre-participation physical evaluation and be certified as being physically fit for participation in interscholastic athletics (form EL2).
- 10. Must be an amateur. This means the student must not accept money, gift or donation for participating in a sport, or use a name other than his/her own when participating. (FHSAA Bylaw 9.9)
- 11. Must not participate in an all-star contest in a sport prior to completing his/her high school eligibility in that sport. (FHSAA Policy 26)
- 12. Must display good sportsmanship and follow the rules of competition **before**, **during and after** every contest in which the student participates. If not, the student may be suspended from participation for a period of time. (FHSAA Bylaw 7.1)
- 13. Must not provide false information to his/her school or to the FHSAA to gain eligibility. (FHSAA Bylaw 9.1)
- 14. Youth exchange, other international and immigrant students must be approved by the FHSAA office prior to any participation. Exceptions may apply. See your school's principal/athletic director. (FHSAA Policy 17)
- 15. Must refrain from hazing/bullying while a member of an athletic team or while participating in any athletic activities sponsored by or affiliated with a member school.

If the student is declared or ruled ineligible due to one or more of the FHSAA rules and regulations, the student has the right to request that the school file an appeal on behalf of the student. See the principal or athletic director for information regarding this process.

Explanation of the FHSAA EL7 Form

1. The FHSAA is an enforcement/governing organization. Its job is to create a "level playing field" for all high school athletes, so that every student has an opportunity to play high school sports in a fair and competitive environment. If there were no Bylaws governing eligibility, recruiting would be rampant and there would be little opportunity for relatively good players to develop their skills on a high school athletic team. Schools that recruit players are penalized and fined for breaking the Bylaws.

The FHSAA Bylaws and the enforcement of them protect home education students and their teams. Having a level playing field allows students to develop their talents and have the opportunity to compete for state championships. Enforcement is difficult, and often misunderstood, but is necessary to protect the integrity of high school athletics.

2. The FHSAA is trying to lessen the number of hours it takes to determine eligibility for each individual home education student. The FHSAA asks for additional information to make those determinations easier. Some of the educational services or vendors that have been reviewed are listed in this document. It takes time to make these determinations on a fair and equitable basis. The EL7 form is not designed to require additional information from home education students, rather to simplify the process and obtain enough information to verify their compliance with state statute and the FHSAA Bylaws.

3. Participation in FHSAA athletics is a privilege, not a right, as determined by the courts. Home education students are given the opportunity to participate, but they must meet the same eligibility requirements as other students in public and private schools. As an example, any public, private or home education student who does not have the required GPA is ineligible to participate in extracurricular activities. All students have to comply with the Florida Statutes and the FHSAA Bylaws to be eligible to participate.

<u>Guide for Completing the FHSAA EL7 Form</u> {Address questions to eligibility@fhsaa.org}

Please read this information very carefully and in its entirety. This is very important and needs to be done correctly for your child to participate in any FHSAA sport program even if they are in a Home Education Cooperative. All forms must be completed and submitted to the Athletic Director, along with any applicable transcript or record of grades. The "Registration Form" is one of the forms used for registering the intent to participate in interscholastic athletics at an FHSAA member school. The forms must be submitted to the school before your child can participate in ANY official practice session.

It is highly recommended that the student begin participating on the first day of practice, to be conditioned, trained and ready to play. You can locate the date of the first practice and first week of regular season competition on the FHSAA Calendar for each sport. However, all information must be submitted to the school <u>PRIOR TO PARTICIPATION</u> in the sport(s) in which the student wishes to participate.

You will need one form for each child who is participating and the form only needs to be submitted one time per school at which the student participates.

"Registration Form"

Section A:

- 1. Give correct information including your child's school grade level for the school year in which he/she is going to participate.
- 2. Provide the name of the county in which the student resides and is registered with as a home education student.

Attach the completed "Verification of Student Registration with Public School District Home Education Office" form (EL7V Form), and if applicable, the "Verification of Student Controlled Open Enrollment Option with Public School District or Charter /Lab School Board" form (EL14 Form).

Note: Controlled Open Enrollment is an option whereby any student could choose to attend a different public school pursuant to § 1002.31, F.S. Home education students must meet the same criteria as a traditional student would to take advantage of this option, i.e. there may be deadlines that apply and space must be available. The EL14 Form ("Verification of Student Controlled Open Enrollment Option with Public School District or Charter/Lab School Board") is required for a student to take advantage of this option.

3. Provide the name of the public (including charter and lab schools) or private school or name of a home school cooperative (as recognized by the FHSAA, which is considered a private school) for which your child will be participating and provide answers relative to they type of school.

List the sport(s) that your child is interested in participating in this year. Make sure to consider all of the sports your child might consider participating in as once this form is completed and notarized the sport(s) listed is/are the only sport(s) your child can participate in without having to re-do this form at a later date.

- 4. Provide the school grade level for the previous school year.
 - a. If your child attended a public or private school last year, select the first choice and give the requested information.
 - b. If your child was registered in a home education program last year, select the second choice and provide the name of the county (or state if different from Florida)
- 5. Enter the date he/she started 9th grade for the first time. If the student is a middle/junior high school student, leave this blank.

A high school student has only 4 years of eligibility, commencing with the school year in which the student enter the 9th grade for the first. A middle/junior high school student has one and only one year of eligibity per grade level. The FHSAA Bylaws do not allow a student to be retained for any reason for grades 6 - 8. Since no student is eligible for high school athletics if the student reaches the age of 19 before September 1st of any school year*, retention most certainly will jeopardize the student's eligibility at the end of his school career.

* for students entering 9th grade for the first time in 2013-14 or earlier, the student must not have reached the age of 19 years, 9 months.

VERY IMPORTANT!!!!

If the student must register with a school in order to be able to take a course at a school, then that school becomes the only school that student can represent (this school may not meet the requirements of the statute and might render the student ineligible). Additionally, a student cannot have registered intent at more than one school at a time; this would render the student ineligible. If the student is taking 50% or more of their courses at a single school, public or private, or an online service other than Florida Virtual School (FLVS), or if records are being kept by any other type school, umbrella school, etc., that has a Florida DOE school number, then the student may not be a home education student and the student is considered to be attending that school and may not be eligible to participate in any FHSAA activities. It is not based on whether the school supplies curriculum, but on whether they are keeping your records for attendance, transcripts, diplomas, and have a Florida DOE school number as private school.

Some families have made the decision to withdraw their students from programs that are "600, umbrella schools," or schools that provide other services in order for their children to be able to continue in athletics.

If you are receiving Educational Services (not just curriculum) from any of the following programs, please answer 'yes' and provide the information requested for (a).

- A Beka Academy (home education option, only);
- Any out-of-state correspondence schools (i.e. American School, Calvert, Alpha Omega Academy, Bob Jones Academy, etc.)

For all schools or programs listed above, the answer to (b) will be 'no' and (c) will be 'yes'; and (d) will be 'yes' if you will be receiving a diploma from them.

Documentation from a school district: The official FHSAA "Verification of Student Registration with Public School District Home Education Office" form (EL7V Form, this form is for the county in which the student resides) and the "Verification of Student Controlled Open Enrollment Option with Public School District or Charter/Lab School Board" (EL14 Form, this form is for the county in which the wishes to participate) can be downloaded from the FHSAA website along with the EL7 form. These forms should be printed out by the parent/legal guardian, completed and authorized by the appropriate school district. Contact the school district to find out the quickest way to get this form authorized (i.e. deliver it in person or fax it to them along with your request). However, you may need to send your request and the form by mail with a self-addressed stamped envelope for them to return the authorized form to you. Be sure you get this form to them as soon as you know your child wants to participate in FHSAA athletics, so that you can meet the deadline for submission of the required forms.

Transcripts or Records of Grades:

A transcript, record or grade report must contain a list of courses taken at a specific school, or through home education, at certain grade levels, and the grade the student earned in that course.

Florida Statute 1006.15(3)(a)(1) does require a 2.0 GPA for all students participating in extracurricular activities. The cumulative GPA in grades 9 - 12 is tied to the requirements for high school graduation in § 1003.4282, F.S. for public school students. A GPA is calculated by converting all grades to a numerical system. The grading scale is set by §1003.437, F.S., and the FHSAA is required to follow thais statute.

For the purpose of athletic participation, the **unweighted** regular grading system must be used (bonus points for honors, AP or IB courses is not permitted). There is a "transcript" or "High School Record" at the end of this document is for use for grades 9 - 12. For students in grades 6 - 8 and for reporting grades for the 1st semester of grades 9 - 12, use the EL 9 Form (available from the FHSAA website).

Generally, the parent will give a grade in the subjects taught in a home education program, unless they use a curriculum or are taking classes through a public or private school, dual enrollment, a distant learning program or FLVS, which provides grades. Most grading in traditional schools is subjective and comparative, except for math. To determine the standard for an "A," the teacher generally has to read 5 to 10 papers or assignments. For an individual home educated student that is not possible. The parent usually knows whether the student is an A, B, or C student. If a student completes all assignments correctly and quickly, he is probably an "A" student. Students who get most of the assignment correct the first time are probably "B" students. If your child is struggling academically, perhaps he/she needs to spend their time on academics and not extracurricular activities. That is the legislative rationale behind requiring a 2.0 GPA for participation in high school athletics.

If your child is currently in high school, you will need to provide their high school subjects, grades, and GPA for each grade level since the student entered the 9th grade. A **cumulative** GPA of 2.0 is required for juniors and seniors according to s. 1006.15(3)(a)(3) F.S. A sample is provided at the end of this document. Students entering 9th grade for the first time need not submit any transcript or record of grades until the conclusion of the first semester; use the EL9 Form to report grades for the 1st semester.

If your child is currently in the 6th through 8th grades, you will need to provide their middle/junior high school subjects, grades, and GPA for the previous semester only. Students entering 6th grade for the first time need not submit any transcript or record of grades until the conclusion of the first semester. Use the EL 9 Form to report these grades.

At any time a student earns a grade through a source other than that solely by the parent/legal guardian, private tutor, or home education group, this must be documented from the issuing institution (i.e. public or private school, FLVS, college or university, correspondence school, etc.) and noted on the transcript or "High School Record".

District documentation must match the institution providing the transcript. For example, if courses were taken in a home education program, then the district documentation must confirm registration in a home education program for those grade levels. Official transcripts from a private or public school will document enrollment in those schools.

The school that you have chosen to attend, or participate for as a "Non-Traditional" student, is a member of the Florida High School Athletic Association (FHSAA). The FHSAA has rules that prohibit a member school from making any effort to encourage or entice a student to attend or participate there for athletic purposes. This is called athletic recruiting, and it is not permitted on the high school level. The Florida Legislature, in fact, has directed the FHSAA to "adopt bylaws that specifically prohibit the recruiting of students for athletic purposes." Florida law also regulates the participation in interscholastic athletics by "Non-Traditional" students.

What follows is an explanation of athletic recruiting rules, as well as regulations related to participation by "Non-Traditional" students, and the penalties for violating them. You and your parent(s) or legal guardian(s) must read this document and declare that you were not recruited to attend or participate for the school for athletic purposes and that you are aware of the regulations regarding participation as a "Non-Traditional" student by signing the attached "Affidavit of Compliance". The signed affidavit must be submitted to the member school prior to a date not earlier than the first day of practice of the first sport in which the student wishes to participate, as posted on the FHSAA Website.

Please read this information carefully. Sign the affidavit truthfully and honestly. Do not sign the affidavit if you have any questions about these rules or believe that a violation of these rules may have occurred. Instead, have your school's athletic director contact the FHSAA Office by phone at 352.372.9551 ext. 340 or by e-mail at compliance@fhsaa.org. Violations of these rules and regulations can and do result in severe penalties for the school and the student-athlete. Making an inaccurate statement by signing the affidavit when you know you should not will only make these penalties worse for all involved if violations are later determined to have occurred.

What is athletic recruiting?

Athletic recruiting is any attempt by any employee or athletic department staff member of an FHSAA member school, a representative of the school's athletic interests or a third party to pressure, urge or entice a student who does not currently attend or participate for that school to change his/her attendance or participation there for the purpose of athletic participation. This occurs when the school employee, athletic department staff member or representative of the school's athletic interests makes improper contact with the student or a member of his/her family in an effort to pressure or urge the student to go to that school OR promises, offers or gives the student an impermissible benefit in an effort to entice the student to go to or participate for that school.

Who is "a representative of the school's athletic interests?"

Any person, business or organization that participates in, assists with, and/or promotes a school's athletic program is considered to be a representative of the school's athletic interests. This includes, but is not limited to:

- A student-athlete or other student participant in the athletic program at that school;
- The parents, guardians or other family members of a student-athlete or other student participant in the athletic program at that school;
- Immediate relatives of a coach or other members of the athletic department staff at that school;
- A volunteer with that school's athletic program;
- A member of an athletic booster organization of that school;
- A person, business or organization that makes financial or in-kind contributions to the athletic department or that is otherwise involved in promoting the school's interscholastic athletic program.

What is improper contact with a student who does not attend a school?

Any contact or communication of any kind with a student who does not attend or participate for a particular school, or a member of the student's family, in attempt to pressure, urge or entice the student to change attendance to a different school for athletic reasons is improper. The improper contact can either be in person, through written or electronic means such as letters, flyers, e-mails, text messages, social media or through a third party. Did someone talk you into changing to this school to play athletics? Did someone urge you to change to this school to play athletics? If so, you may have been athletically recruited.



Affidavit of Compliance with the Policies on Athletic Recruiting & Non-Traditional Student Participation

What is an impermissible benefit?

An impermissible benefit is any benefit that is promised, offered or given to a student or a member of his/her family but is not offered or generally made available to all students who apply to or attend or participate for the school. Did someone promise, offer or give you anything more than what any other student who attends or participate for this school is generally promised, offered or given that caused you to decide to change to this school? If so, it probably is an impermissible benefit.

What is a "third party"?

A "third party" is an independent person, business or organization who may or may not be a representative of the school's athletic interests.

What are the penalties for violations of athletic recruiting rules by a member school?

A member school that violates athletic recruiting rules will be assessed one or more of the following penalties:

- A public reprimand;
- A financial penalty;
- Forfeiture of all contests and awards won in which the student who was athletically recruited or received an impermissible benefit participated or contributed;
- One or more forms of probation (administrative, restrictive or suspension) for one or more years;
- Prohibition against participating or coaching in certain competitions, including state playoffs, for one or more years in the sport(s) in which the violation(s) occurred;
- Prohibition against participating in any competitions for one or more years in the sport(s) in which the violation(s) occurred;
- · Restricted membership for one or more years during which some or all of the school's membership privileges are restricted or denied;
- Expulsion from membership in the FHSAA.

What are the penalties for a student who is found to have been athletically recruited or receives an impermissible benefit?

A student who is found to have accepted an impermissible benefit will be ineligible for athletic competition for one or more years at the school where the violation occurred, and may be declared ineligible for athletic competition at all FHSAA member schools for one or more years.

What are the regulations regarding the participation of "Non-Traditional" students?


A Non-Traditional student is eligible to participate provided:

- The student meets the same residency requirements as other students in the school at which he/ she participates; and
- The student meets the same standards of acceptance, behavior and performance as required of other students in extracurricular activities; and
- The student registers with the school his/her intent to participate in interscholastic athletic competition as a representative of the school, utilizing the official Association process as approved by the Executive Director, <u>prior to participation</u> in the sport(s) in which he/she wishes to participate, as posted on the FHSAA website; and
- The student complies with all FHSAA regulations, including eligibility requirements regarding age and limits of eligibility, and local school regulations during the time of participation; and
- The student provides proof of basic medical insurance coverage and both independently secured catastrophic insurance coverage and liability insurance coverage which names the FHSAA as an insured party in the event the school's insurance provider does not extend coverage to such students; and
- The student provides his/her own transportation to and from the school; and
- The student provides to school authorities all required forms (including, but not limited to, the EL2, EL3 and, where applicable, the EL7, EL7V, EL12, EL12V and EL14) and provisions.

What are the penalties for violations of regulations regarding "Non-Traditional" student by a member school?

Allowing students to participate without properly registering a non-traditional student will subject the school to a monetary penalty.

Submission of this form **DOES NOT** grant eligibility. The student must be **ELIGIBLE** in all other respects.

No employee, athletic department staff member, representative of the athletic interests of THIS SCHOOL, any person or organization acting on their behalf or a third party is giving, has given, has offered or promised to give, directly or indirectly, through intermediaries, or otherwise any impermissible benefit to THIS STUDENT or any member of his/her family for the purpose of participation in interscholastic athletics.

5. If THIS STUDENT is a "Non-Traditional" student, THIS STUDENT has submitted to THIS SCHOOL the EL2 and EL3 forms and, where applicable, the EL7, EL7V, EL12, EL12V and EL14 forms prior to participation in the first sport in which the student wishes to participate.

6. If THIS STUDENT is a youth exchange (J-1 and F-1 Visas), international or immigrant student, THIS STUDENT has submitted to THIS SCHOOL the EL2 and EL3 forms and, where applicable, the EL4 Form.

Under penalties of perjury, I declare that I have read the foregoing Affidavit and that the facts stated therein are true and correct and that the punishment for knowingly making a false statement includes fines and/or imprisonment. I further understand that the penalties for knowingly making a false statement may subject THIS SCHOOL to fines, forfeitures, probations and possible expulsion from membership in the FHSAA, and may subject THIS STUDENT to a loss of athletic eligibility.
