WAIVER FORM

COVERING: RELEASE OF LIABILITY, ASSUMPTION OF RISK, HOLD HARMLESS, AGREEMENT TO INDEMNIFY AND NOT TO SUE FOR MINORS PARTICIPATING IN THE COLUMBUS JUNIOR GOLF ASSOCIATION PROGRAM.

I hereby give my consent for the below named minor to participate in the Columbus Junior Golf Association (CJGA) Middle School program. I understand that CJGA is operated under the Columbus Golf Authority (CGA) which is part of the Columbus Consolidated Government (CCG) and any reference to CJGA includes CGA and CCG. Individually, and as a parent or legal guardian of the minor ("I"), I understand that the minor's participation in CJGA involves potential personal and property risks. Injuries may be serious or minor, including but not limited to: head or neck injuries, loss of sight, broken bones, brain damage, paralysis, and death. I hereby certify that I know the minor's state of health and well-being and that the minor is physically fit to participate and has/will have health insurance while participating in CJGA golf programs. I expressly understand and agree that the minor agrees to abide by all policies, rules, and regulations of the CJGA. I expressly assume any and all risks of injury and/or death associated with, arising out of or related to the minor's participation in the CJGA. I expressly understand that the CJGA, coaches, or volunteers assume no responsibility for the minor's negligence or willful misconduct, or that of others. Recognizing and understanding the potential risks of injury, I agree not to sue and to defend, indemnify and hold harmless the CJGA, its officers, trustees, agents, representatives, volunteers, students, coaches, and employees, or assigns from all liability associated with, arising out of, or related to the minor's participation in the CJGA including all liabilities associated with and any and all claims that may be filed on behalf of or for the named minor. I agree that this release of liability, assumption of risk, hold harmless, agreement to indemnify and not to sue, is legally binding on me, the minor, our heirs, personal representatives, relatives and assigns and that I am giving up both my and the minor's legal rights and remedies which otherwise would be available to me and/or the minor, our heirs, personal representatives, relatives or assigns against CJGA, its officers, trustees, agents, representatives, volunteers, students, coaches and employees. I have carefully read this release of liability, assumption of risk, hold harmless, agreement to indemnify and not to sue and fully understand it. I have explained the significance of this release of liability, assumption of risk, hold harmless, and agreement to indemnify and not to sue to the minor.

- A Team/ Advanced-Parents are not allowed to give advice or talk to a player during a match.
- B Team-Parents can assist a player from tee to green, but not on the green.

***Parents and spectators will be given a warning by the Host Coach for the first offense but may be asked to leave for a second offense.**

- No smoking
- No cell phones for players (Parents should silence theirs)
- Spectators may act as fore caddies only
- Abusive or inappropriate language will never be tolerated
- Advanced players must carry their own clubs, non-motorized pull carts allowed
- Advanced parents and spectators must maintain a 30+ yard distance from players
- Advanced parents and spectators who rent carts must stay on the cart paths at all times
- At no time should a parent/spectator cart be in the fairway
- No alcoholic beverages
- Please read, understand and practice the CORE VALUES of the CJGA program
