## **FWISD Stadium Tailgating Guidelines**

### **General Guidelines**

- A gathering of a group of people in a pre-game setting outside of the stadium grounds, usually in the parking lot area, where fans gather to socialize, eat, drink, or play games, is considered a tailgating event.
- Tailgating is permitted in designated areas only.
- All tailgating activities must shutdown at kickoff time (no exceptions).
- Tailgating hours are between 4:00 p.m. and the kick-off of the football game.
  - Kickoff times on Thursday & Friday - 7:30 p.m.
  - Kick-off times on Saturday - 10:30 a.m. (start times on Saturdays can change)
- Tailgating groups of +10 people must sign the Tailgating Agreement form with the FWISD Safety & Security Department.
- Student groups associated with the campus must get approval from campus administration and the Athletic Department for a designated tailgating area.
- Glass containers or bottles are not allowed in the parking lot.

### **Parking and Setup**

- Vehicles must park as directed by staff.
- No saving parking spaces or expanding beyond the assigned area.
- No early parking or overnight parking to reserve spots.
- Canopies, grills, and seats must be confined to the designated space.
- ADA and EV parking spaces cannot be used for tailgating.
- Entrance and exit gates to the parking lot cannot be blocked or impede the flow of traffic.

### **Safety and Conduct**

- Open flames must be contained and monitored.
- Fire extinguishers are required at each grilling station.
- Loud music, disorderly conduct, or offensive language is prohibited.
- Hired security personnel must be approved by FWISD Safety and Security prior to an event.

**Clean-Up**

- Trash must be disposed of in designated bins.
- Tailgaters are responsible for cleaning the area at shutdown time.
- Failure to clean up may result in fines or loss of tailgating privileges in the future.

**Prohibited Items**

- Charcoal Grills
- Propane cylinders larger than 20 lbs.
- Amplified sound or excessively loud music
- Any alcohol, drugs, or drug paraphernalia
- Bottles or glass containers
- Tobacco products
- Pets that are not registered service animals
- Drones
- Fireworks
- Motorized vehicles (e.g., golf carts, scooters, ATVs)
- Firearms, knives, or any objects that can be used as a weapon

**Enforcement**

- Violations may result in ejection, fines, or revocation of tailgating privileges.
- FWISD Safety & Security and law enforcement will monitor compliance.
- FWISD Safety & Security team can eject any participant, at any time, in their sole discretion.

**Designated Tailgating Locations**

- Herman Clark Stadium
- Farrington Field
- Scarborough Handley Field – Due to limited parking spots at the stadium, tailgate set ups will not be allowed inside the stadium parking gates.

**The Fort Worth Independent School District (District) reserves the right to amend these guidelines, limit tailgating privileges, and discontinue tailgating at its discretion.**

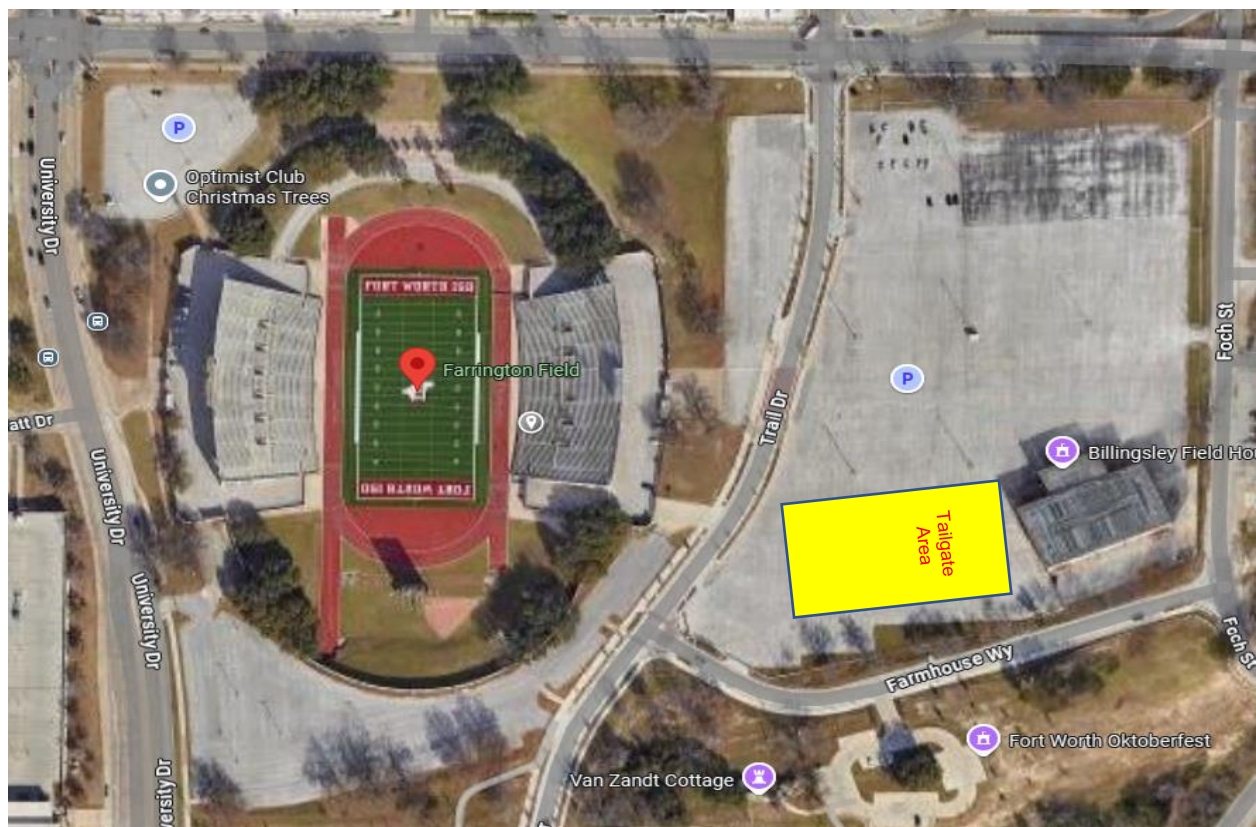
